Nominations will be accepted only from members in good standing of Victoria Lodge 1735. Nominations for delegates must be received by the Grand Lodge no later than a year at the time of nomination and from those subsequently to the Grand Lodge and Grand Lodge.

Electors for the delegates will be held at the meeting of Grand Lodge 1735 at 8 P.M. on the following day, to-wit: Thursday, June 10, 1884, 8:00 P.M. - 8:00 P.M., Victoria Lodge 1735, 1735 Main Street, B.V. 1735, Victoria, B.C. 1884. Only members in good standing of Grand Lodge 1735 are eligible to vote at this election.

The Secretary will receive the highest number of votes in each ward and he should declare to the Grand Lodge the number of votes. In accordance with the Grand Constitution, any member entitled to receive an election ballot shall declare a written statement to the Secretary Secretary of Grand Lodge 1735 on June 10, 1884 before the election.
